1. You are invited to submit your most competitive quotation for supply of Handlooms & accessories and Computer Aided Textile Designing machine (CATD) along with operating software for the following specifications:

2. North East Rural Livelihood Promotion Society intends to apply a part of the proceeds to eligible payments under the contract for which this invitation for quotation is issued.
3. **Bid Price**
 - a) The contract shall be for the full quantity as described above. Corrections, if any shall be made by crossing out, initialing, dating and rewriting.
 - b) All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
 - c) Sales Tax/GST in connection with the sale shall be shown separately.
 - d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.

- e) The price shall be quoted in Indian Rupees only.
 - f) **Copy of PAN & GST Registration certificates**, EM part II/trade License (self-attested) are required to be submitted with quotation. The GST certificate should indicate the specific item/product being dealt by the firm. A certificate from the banker is to be enclosed indicating bank account being maintained in favour of the firm.
4. Each bidder shall submit only one quotation. Bidder shall not contact other Bidders in matters relating to this Quotation.

5. **Validity of Quotation**

Quotation shall remain valid for a period not less than 45 days after the deadline date specified for submission.

6. **Evaluation of Quotations**

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which,

- a) are properly signed ; and
- b) Conform to the terms and conditions, and specifications.
- c) The Quotations would be evaluated together for Handlooms sets & accessories (Annexure-1) and Computer Aided Textile Designing machine (CATD) (Annexure-2) would be evaluated separately.
- d) GST in connection with sale of goods shall not be taken into account in evaluation.


7. **Award of contract**

- 7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
8. Payment shall be made within 20 working days after delivery of the goods and submission of acceptable bills.
9. Normal commercial warranty/ guarantee shall be applicable to the supplied goods.
