Sub: Invitation of quotation for hiring of vehicles.

You are invited to submit your most competitive quotation for hiring of vehicles on monthly/daily rental basis in the Regional Project Management Unit, North East Rural Livelihood Project at Guwahati.

Brief Description & Eligibility:

- NELPS intends to avail services of a reputed and experienced Travel Agency for hiring of vehicles on monthly & daily rental terms (as required from time to time) in Regional Project Management Unit, North East Rural Livelihood Project. (Details are as attached). The initial duration of the contract shall be for a period of one year. The contract may be renewed for further periods on mutually agreeable terms.
- The Travel Agency should be registered with the appropriate authority and must have GST Registration No., Trade License and Income Tax Permanent Account Number with at least 3 years of experience in providing similar services to reputed Organizations/ Institutions.
- The Agency shall have to provide the vehicle with driver having valid driving license and insurance. The Agency should own at least three vehicles in good condition (which are not more than 2 years old). At least two vehicles should be available for on call duty with per day cost basis. The Agency has to provide details of the three vehicles owned by the agency with the details namely Registration Certificate (RC), insurance etc. Further the Driving License of the drivers to be enclosed herewith.
- One vehicle should be supplied for rental on a monthly basis which should preferably be a new one (white colored) but not older than a year on the date of agreement. The supplied vehicle shall be for whole time and will be under the disposal of RPMU.
- The Agency shall be responsible for paying all expenses related to repair, maintenance, fees, taxes raised by local authorities. However, the toll tax, if any, shall be reimbursed on production of receipt. Agency should maintain a regular log book for the vehicle placed.

Bid Price

- (a) The financial quote for the rate offered should be mentioned separately for daily/monthly basis and monthly basis as per the format attached.
- (b) All duties, taxes and other levies payable by the supply contractor under the contract shall be included in the total price and should be shown separately.
- (c) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to change/ adjustment on any account.

Validity of Quotations

Quotation shall remain valid for a period of not less than 30 days after the deadline date specified for submission.

Evaluation of Quotations:

The Client shall evaluate and compare the quotations determined to be substantially responsive, i.e., which are properly signed and confirm to the terms and conditions. The quotations would be evaluated separately for each item.


Award of Contract

- (b) The bidder whose bid is accepted will be notified of the award of the contract by the Client prior to the expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the offer order.
- (c) Payment shall be made on monthly basis within 15 days from receipt of bill along with log sheet record.
